### About Ipsos MORI

- Market & Opinion Research International Limited is a specialist research agency, commonly known as "Ipsos MORI". Ipsos MORI is part of the Ipsos worldwide group of companies, and a member of the Market Research Society. As such we abide by the Market Research Society Code of Conduct and associated regulations and guidelines.

### What personal data has Ipsos MORI received for this survey?

- Ipsos MORI has personal data relating to your business because we have been asked by the Department for Digital, Culture, Media and Sport (DCMS) to carry out anonymous survey research on their behalf; the Cyber Security Breaches Survey. - DCMS has securely shared, with Ipsos MORI only, a limited amount of personal data relating to your organisation so that we can invite you to take part in this research survey. This has been taken from the Inter-Departmental Business Register (IDBR), which is a list of UK businesses maintained by the Office for National Statistics (ONS) for statistical purposes. The ONS data was securely shared between ONS and DCMS on 13/09/2018 under licence for a limited time until 31/03/2019, upon when it is scheduled to be securely destroyed by DCMS.
- The personal data that DCMS has shared with Ipsos MORI for this survey is:
  - organisation registered and trading names
  - organisation address and postcode
  - organisation telephone number
  - contact name within the business where available.
- Based on this information, Ipsos MORI has also obtained personal data (name and contact details of individuals in charge of cyber security) for the purpose of the survey.

### What is Ipsos MORI's legal basis for processing personal data?

## **How will Ipsos MORI use any personal data, including survey answers provided by participants?**

- Responding to this survey is voluntary and any answers are given with your consent.
- Ipsos MORI will use your personal data and answers solely for this statistical research purpose. This includes producing anonymous, aggregated statistical research findings for DCMS. Ipsos MORI will provide DCMS with a de-identified data file of responses for them to carry out their own analysis and quality assurance of the results. This de-identified file may be made available to other approved Government Departments, partner organisations or researchers for statistical research purposes only. Your personal data (including any contact information) will not be included in this data file.
- Ipsos MORI will therefore keep your personal data in confidence, in accordance with this Privacy Notice. Ipsos MORI can further assure you that you will not be identifiable in any published results.

## **How will Ipsos MORI ensure personal information is secure?**

- Ipsos MORI takes its information security responsibilities seriously. We apply various precautions to ensure your information is protected from loss, theft or misuse. Security precautions include appropriate physical security of offices, and controlled and limited access to computer systems.
- Ipsos MORI is accredited to the International Standard for Information Security, ISO 27001. In line with this, we have regular internal and external audits of our information security controls and working practices.

## **How long will Ipsos MORI retain personal data and identifiable answers?**

- Ipsos MORI will only retain any personal data and identifiable answers for as long as is necessary to support this research. In practice, this means that once we have reported the final anonymous research findings to DCMS, we will securely remove any personal data from our systems.
- For this project, we will securely remove your personal data from our systems by 5 July 2019.
